Frances specialises in family law work, including divorce and complex children's cases. She is also a senior mediator. Frances has been a starred lawyer in the Chambers directory and a leading lawyer in the Legal 500 for many years.

Frances is also listed in Tatler Address Book's *Advisory* as founding partner and one of the leading family lawyers in their trusted network of influential and elite private client experts with "gilt-edged" expertise.
